Mobile Device User Agreement and Contract

We know that the use of technology for learning, communicating, working, travelling, shopping, socializing, etc. will only increase in the future. Because of this, NCS has placed an emphasis on the use of technology for academic and professional purposes. As part of this focus, each student in grades 4-12 is assigned a mobile device for the school year. Our goals for this initiative include:

- To increase student productivity and engagement
- To continue movement towards student-centered learning
- To teach students how to use mobile devices as academic and professional tools
- To increase collaboration, creativity, critical thinking and communication

Distribution/Collection

Devices will be distributed at the beginning of the school year and must be returned at the end of the school year. They may also be collected at various times during the year for maintenance and updates. If a student leaves NCS during the academic school year for any reason at all, the device will be returned to the school a week before departure.

Broken or Damaged Devices

The District will provide adequate protection (cases) for the devices and some normal wear and tear is to be expected. However, financial responsibility for lost or damaged devices will be assumed by students/families at the following rates:

Cracked screen	\$50
Dented device (rendering it unusable)	\$50
Lost charger	\$10

Parents will be notified of damages by an initial phone call home and will subsequently receive an invoice from the business office. We are also happy to work with families on a payment plan.

District Owned Devices

iPads and Chromebooks are district owned devices and the contents on the iPad or Chromebook can be viewed at any time. The student should have NO expectation of privacy of materials found on a school supplied device or school supported email service.

Internet Connectivity

While at school, students will be accessing the Internet through the NCS network, which follows the required Children's Internet Protection Act (CIPA) regulations.

When the device is out of school, it will access any available WiFi and follow the Internet controls associated with that network. We recommend that you talk to your children about the standards they should follow on the Internet just as you would on the use of all media information sources. We also recommend that student use of the Internet is monitored by an adult.
