

## **Providing Opportunities for All Students**

On Tuesday, May 17, 2016, the Naples CSD community will vote on a proposed 2016-2017 school budget that preserves the current year's programs, services, and staffing.

The \$19,735,890 budget increases the tax levy by an estimated 1.16%, which is within New York State's allowable Property Tax Cap and represents a 0.85% change in spending.

Throughout the budget development process, the Naples Board of Education kept a clear focus on aligning the district's values and priorities with its spending plan. "This fall we listened carefully to staff members and parents who stressed the importance of supporting all of our pre-kindergarten and kindergarten students who lack school readiness skills," said Superintendent Matt Frahm.

"Because research shows that if a student is not reading proficiently by 3rd grade they are four times more likely to leave school without a diploma, we have made sure that this budget provides appropriate literacy support

in the form of staffing, training, and teaching materials.' The end of the Gap Elimination Adjustment (GEA) has also helped provide the

resources needed to restore an Elementary School Ski Club, funds for classroom field trips, and the creation of a replacement plan for purchasing musical instruments. "We find that our most successful students are also the ones who are the most involved, and we want to make sure we are providing them with dynamic opportunities related to the arts and athletics," said Frahm. "Our school and the children we serve are better because of our supportive community, and we hope everyone will remember to vote on May 17."

# **Establish Capital Reserve:**

- a. Authorization to establish a capital reserve fund (savings account) to be used to finance in whole or in part the acquisition of transportation vehicles in accordance with Education Law section 3651
- b. Ultimate amount not to exceed \$750,000, plus interest, for a term of 10 years, or until liquidated
- c. Future reserve funding sources could include unappropriated fund balance, budget appropriation, transfer from reserves

# **School Funding Changes**

### Within Tax Cap Again Fifth Year in a row

Legislation signed into law in June 2011 requires districts to calculate their own tax levy limits annually. The law requires use of a complicated formula based on several factors.

### Contingent Budget

Under state law, school boards can submit a budget to voters a maximum of two times. If the proposed budget is defeated twice, the board must adopt a contingency budget. The board also has the option of going directly to a contingent budget immediately after the first budget defeat. Under a contingent budget, the district must adopt a budget with the same tax levy as the prior year - essentially a zero percent cap -resulting in \$59 thousand in cuts.

# **Gap Elimination Adjustment**

A mechanism implemented by the state that significantly reduces state aid allocations to each district. These funds are then moved to other parts of the state budget to reduce the state's debt. Since 2010, the state has taken almost \$8.5 billion in state aid from NYS schools. Naples has lost over \$3 million as a result of the GEA. The state has now ended the GEA and the district should see no further reductions as a result.

## Tax Cap Override or "Super Majority"


A school district may choose to go beyond what is allowed in the tax levy limit formula at which time voters must obtain approval with a 60 percent majority. This is commonly referred to as a "Super Majority." If a Super Majority vote fails, the board of education has the option of going out to vote one more time on the same, or amended budget, or, exercising the terms under a contingency budget. If the budget is defeated twice, the board must adopt a contingency budget.

# 6 - 2017 Three Part Budget


Proposed Budget Expenditures (State-required three-part budget)

## **Administrative** Component \$1,873,096

The Administrative Component provides for overall general support and management activities including:

- · District Clerk and Superintendent's office
- Business office operations Personnel, legal, liability and property
- insurance
- Auditing services
- · Costs for the administration and supervision of each of the District's two schools
- Employee benefits for all administrative and clerical support staff including social security, workers' compensation, pensions, health insurance and unemployment

## Capital Component \$3,784,432

The Capital Component pays for:

- · Maintaining two schools and one additional building
- Upkeep of over 25 acres of property
- · Electricity, gas heat, water and telephone services
- "Mortgage" or debt service payments on capital projects (principal and interest payments)
- Refund of taxes for claims against property assessments
- Benefits for maintenance and custodial staff including group health insurance, social security, non-teaching retirement, workers' compensation, life, disability and an employee assistance program

## **Program** Component \$14,078,362

The Program Component provides funding for the instruction of and educational support services for the District's students. Funds are also included for:

- Transporting approximately 550 students
- · Salary expenditures for instructional staff
- Related support personnel in K-12 programs
- Programs for Special Education services Benefits for approximately 220
- instructional employees, including over 70 retirees in group health insurance
- · Social security, teacher and non-teaching retirement
- Workers' compensation, group insurance (life, health, dental, disability), employee assistance program and unemployment insurance
