Points of Interest:

Board Member John Murphy stated on Sunday January 13<sup>th</sup> at 4:45 p.m. Naples Junior Samantha Bell would be participating in a vocal contest sponsored by Rotary International at Robert's Wesleyan College, noting if anyone is interested in attending he would let them know how to get there.

Board Member Mona Sage-Cardinale stated there would be a Naples Community Garden meeting at 7:00 p.m. in the Memorial building located between the Trinity Federated Church and the Naples Baptist Church, noting they will be discussing how the school can participate in the Community Garden, adding the students may be able to help with planting, or developing a pick your own pumpkin patch, or perhaps even growing food for distribution through the Open Cupboard.

Recognitions and Updates:

Superintendent Ward welcomed the students attending the Board of Education meeting for their Government class, noting the board likes to see the students learning more about our local government, specifically how it relates to the School District.

Regular Meeting January 9, 2013

Superintendent Ward stated they would be recognizing the students who volunteered for Operation Santa this year, noting Operation Santa is a strong Naples tradition that has been around for a long time, adding it is a true partnership between our student volunteers and members of the Naples Rotary who deliver the packages.

Secondary Principal Matthew Frahm recognized the students who participated in Operation Santa, noting the students participating in Operation Santa keep a low profile as a lot of what they do is very confidential, commenting he is always amazed at how they reach out and connect with different businesses and individuals in the community, noting it is a powerful web when you look at all the people involved in Operation Santa. Mr. Frahm stated that Operation Santa had managed to reach out and help fifty-three families, one hundred and forty children, and fifty seniors, adding that is a pretty incredible number and the school appreciates all that they do to make the holiday season a special time for kids in this community. Board Member John Murphy stated he had delivered baskets to senior citizens in the community for Rotary, noting it was nice to see how appreciative they were to receive the baskets.

Capital Project Update:

Financial Consultant Bernie Donegan presented information pertaining to borrowing for the Capital Project, noting the building aid reimbursement rate has not dropped for the last three years, adding for each dollar we spend as a District that is aid eligible we are reimbursed by the state over a period of fifteen years, stating the current reimbursement rate is 63.7 %. Mr. Donegan noted the Board of Education had authorized additional contractors for Phase 2b at the December Board of Education meeting therefore we will need to borrow additional cash in June to pay the contractors. Mr. Donegan then reviewed the Financing Time Line and the Capital Project Projected Cash Flow, noting they are trying to minimize the expense to the District throughout the project. Mr. Donegan stated that so far in this project, interest expense has not been a problem as the current rate is 1% with the net interest cost to the school of 0.57% which is an excellent rate. Mr. Donegan stated the long-term mortgage proposal is a fifteen year payback, noting next year will be the first year we will have to start paying back.

Todd LaBarr of Watchdog Building Partners and Victor Tomaselli of SEI Design Group then presented a brief update of the construction project. Mr. LaBarr stated they are in a transition period between Phase 2 a and Phase 2b, noting there are some very minor items to be completed for Phase 2a with final applications for payments to be received this month. Mr. LaBarr noted they have been working with Phase 2b contractors to get their bonds and insurance in place, adding the contractors have started and are currently working to disconnect services to the pool area in preparation for demolition, noting on January 16<sup>th</sup> the large equipment will arrive for the demolition. Mr. Tomaselli stated he wanted to stress safety in the work area as there will be large equipment, adding the construction fencing is in however we need to be sure students and staff are not exiting near the construction area unless it is an emergency situation.

Career & Counseling Department Chairperson report was presented by Monica Kastner. (Report attached)

New Media Course Presentation:

Teacher Anneke Radin-Snaith presented information on the proposed twenty week media courses, Social Media and Digital Media Creation, followed by a period of questions and answers pertaining to the information presented.

Students in the Spotlight:

Elementary Principal Kristina Saucke read the names of the December Students in the Spotlight (attached), noting the students' pictures can be seen in the Elementary school hallway.

Budget Update:

School Business Administrator Mitchell Ball presented the budget update, noting as they work to develop the budget they are looking for avenues to keep up with what is going on at the state level, legislatively and in the Governor's office, adding he and Superintendent Ward had listened to a webinar on how a bill becomes a law which was a precursor to the way the legislature and the Governor pass their budget. Mr. Ball stated the important items that came out of the presentation were that the legislature requires the governor's executive proposal be submitted by January 22<sup>nd</sup> and the legislative budget is required by law to be submitted by April 1<sup>st</sup>, adding once that budget is in place the District can move forward and make the decisions we need to make as an educational institution.

School Business Administrator Mitchell Ball stated he and Superintendent Ward had also listened to Governor Cuomo's State of the State address, noting Governor Cuomo did not have a lot to say about how funding will look for education this year, adding the education reform commission formed last April put out a report last week which did not include any recommendations for new or additional funding but instead they stated that school districts should look to leverage existing resources to fund education, adding it does not look good for educational funding and we may be looking at either flat funding or possible a decrease of funding. Mr. Ball stated the District is currently waiting for the executive proposal to be submitted.

Superintendent Ward discussed what Governor Cuomo talked about in the state of the state address, noting the Governor is looking to revitalize upstate New York as the job growth rate in upstate New York is at 5% compared with 11% for New York State as a whole; 16% for New York City; and 9% nationally. Mrs. Ward reviewed Mr. Cuomo's ideas for revitalizing upstate New York. Superintendent Ward stated Mr. Cuomo also challenged School Districts to increase student learning time and increase the number of student days per school year noting the state would provide 100% of the cost to extend the student learning time. Discussion followed pertaining to information presented.

Safety & Security:

Superintendent Ward stated she had wanted to address the incident in Sandy Hook, noting it has been on everyone's minds, adding our District has reached out to the Ontario County Sheriff's Department as well as the New York State Police Department and the District & Building Level Safety Teams to review our procedures to see what safety procedures we can improve here at Naples. Mrs. Ward stated there are buzzer systems being installed in both buildings that will be connected to an intercom and camera for access, so doors will be locked throughout the day, adding the District is also looking at access to the building after school hours, trying to balance community use and public access to the building with safety issues. Board President William Kelly stated he would like to have a school resource officer back in the District as we are nineteen miles away from the county sheriff or state police offices. Discussion followed pertaining to safety & security in the District.
