Board President William Kelly asked everyone to stand for the Pledge of Allegiance.

Public Comments:

Science and Math Teacher and President of the Naples Teachers' Association (NTA) Dan Robinson, requested on behalf of the NTA that extra money allocated from the state be used to restore proposed program and personnel cuts; asked the Board of Education if they had reviewed the resolution asking the NYS Commissioner of Education and the Board of Regents to stop the over reliance on standardized tests, requesting that the board approve the resolution and send it to the Commissioner; stated that during the recent safety drill there were some mock shootings where guns were actually aimed and discharged directly at people and he found that incredibly upsetting, noting basic gun safety teaches us not to ever point a gun at a person even with blanks, encouraging the District not to hold that type of drill again.

Student Ben Pulver, with student McKayla Johnson addressed the Board of Education as members of Operation Santa, stating that they know the board does not want to see Operation Santa end, that we all want to see Operation Santa continue, adding as members of Operation Santa for two years they wanted to offer some thoughts and solutions of their own: 1. In looking at the proposed budget they felt the SRO position should be removed and the Operation Santa stipend returned, commenting that they understand the protection of students is very important however they felt one SRO between two schools would not provide the safety that the District desires and would only offer a false sense of security; 2. Divert some of the funds raised through donations to Operation Santa to cover the cost of the advisor's stipend, noting they understood they would not be able to serve as many families as they currently do however even serving one family is worth more than not being able to serve any family because the program is no longer able to continue, adding both of the solutions boil down to one thing, that members of Operation Santa are willing to work with the school board and with the school administration in order to develop a solution, suggesting forming a committee to work on the issue, adding they are open to a variety of solutions as long as there is cooperation and communication. Mr. Pulver stated that in their opinion the very best solution was to continue the stipend for the 2013-14 school year while simultaneously pursuing some option to outsource Operation Santa to an outside volunteer organization, noting that would give them the time to prepare for the transition and by creating a plan for the future that would resolve future issues, adding any discussions on potential solutions should involve members of Operation Santa as they are the people who know what it takes to run an organization like Operation Santa and it would be a shame if the board were to forgo their expertise and venture out on their own.

Board Member Mona Sage-Cardinale announced the Naples Student Association (NSA) is hosting a craft show in the Naples Elementary Gym on May 4th from 9:00 a.m. to 3:00 p.m., adding if anyone is interested in participating the booths are 10' x 10' for \$25 and they should contact Tammy Brace at tbrace@naplescsd.org for further information, noting that the NSA funds many activities at the school including student field trips, the ice cream social, etc. each year.

Superintendent Recognitions & Updates:

Superintendent Ward thanked those present who brought a food item for the United Way Food Drive noting there are boxes available in both the Secondary Building and the Elementary Buildings for donations through April 17th, adding the District is partnering with the Naples Rotary to collect as much as we can and all donations will go directly to the Naples Food Cupboard.

Superintendent Ward announced that Senator O'Brien would not be able to attend that evening.

Capital Project Update:

Superintendent Ward noted that the Board of Education members had taken a tour of the capital project site and renovated High School cafeteria area. Todd LaBarr of Watchdog Building Partners presented an update on the capital project information pertaining to the project, noting they are very happy with the progress of the project. Mr. LaBarr stated they will be taking over the High School gym area as of May 1st to begin renovations in that space with the intent to have that area ready for use for the 2013-14 school year. Mr. LaBarr then reviewed those items completed; currently being worked on and upcoming in the project, complimenting the contractors, noting they have made great progress and the contractor's ability to complete as much work as they did over the winter months really puts the District in a good position to hit the target turnover dates included in the phasing plan.

Vic Tomaselli of SEI Design Group stated they are all thrilled with the way things are going, noting this has been a very successful project from the start, adding a successful project requires a team effort, noting this team has been remarkable and communication has been great between the school, design team, building partners and contractors, so the project is going very well.

Keyboarding:

Superintendent Ward stated keyboarding has been typically taught at the secondary level, noting in the past it was taught in 9th grade and has now been moved to the 7th grade. Mrs. Ward stated with the regents reform agenda and the State Education Department push towards online testing that we believe is coming in the 2014-15 school year, the District wants to make sure the students are prepared to take the online tests, adding the District has been working very hard to get the hardware and software set up to handle all the students for online testing however the students need to be skilled enough to sit for these assessments and take the test online. Mrs. Ward stated the District has had a lot of conversations about moving keyboarding to an appropriate level to ensure that the students are prepared when they begin the 3rd grade ELA and Math assessment online so they are recommending that our 3rd grade students have keyboarding and also provide keyboarding for the 4th grade students for next year as well as they will not have had keyboarding in their third grade year, with the understanding that the 3rd grade students will be getting keyboarding from here forward so that they are prepared for taking online exams.

Budget Update:

Board President William Kelly stated this year's budget has been razor thin, thanking everyone for their input, also thanking those who took the time to go to Albany, wrote letters and made phone calls in support of the schools, noting their work was effective as the District received restoration aid of about \$200,000 that the District was not expecting. Mr. Kelly stated the Budget Committee had met to determine where best to use the restoration aid and recommended that the District do everything it can to meet the Part 100 Regulations regarding the requirements for Physical Education minutes; use less of the District's reserve funds; return some money to the Special Education budget to cover any unforeseen student needs; return stipends for Operation Santa and Foreign Language Clubs, noting this may not be sustainable for future years however it will buy the District a year to prepare, adding the District expects one more really tough budget year; and reduce the amount cut from the Ski Team budget, noting the Ski Team has an excellent parent group who fundraises to help cover any additional costs.

School Business Administrator Mitchell Ball and Superintendent Ward presented information pertaining to the proposed 2013-14 School Budget, reviewing the state budget adjustments; proposed budget overview; the estimated tax levy impact; and vote details and dates.

Superintendent Ward reviewed Chapter 7 of the Mindset book noting the chapter talks about changing how we approach things and maintaining a positive attitude. Board discussion followed pertaining to the book.
