Board Response:

Board President William Kelly responded to two items brought up at a previous meeting:

1. Mr. Kelly stated the Board of Education was asked to sign a document to the State of New York saying that the board would not support the core standards and testing, noting at this point in time the board is not willing to do that and is currently talking to legal counsel about the issue.

2. Mr. Kelly also noted the board has investigated each and every question or suggestion brought to their attention in relation to the recent active shooter drill at the High School.

Points of Interest:

Board Member Mona Sage-Cardinale stated the Finger Lakes Museum, to be located in Branchport, has received a NYS matching funds grant so the Museum is working hard to raise

the money needed to meet the matching funds requirement with an "It's about us. Keeping the US in Museum Campaign", noting you can get information on the museum and the fundraising campaign at the museum's website, fingerlakesmuseum.org. Ms. Sage-Cardinale stated the museum has free canoe and kayak rentals on Sundays which is very nice for families as it is right on Keuka Lake, adding they have also rescued two eagles which are currently being raised in Springwater, however the museum's plans are to renovate the old Branchport School into an eagle habitat where families can view the eagles.

Board Member Mona Sage-Cardinale also announced the NSA would be holding a Craft Show on Saturday May 4th from 9 a.m. to 3 p.m. in the Elementary Gymnasium, noting there will be quite a few vendors and raffles of products donated by the vendors.

Board Member John Murphy stated the annual Band Booster Golf Tournament was also being held on May 4th at noon at the Reservoir Creek Golf Course, noting if anyone needed further information to contact Band Director Phil Bariteau and Elementary teacher Kayc Cass-Northrop.

Superintendent Recognitions and Updates:

Superintendent Ward welcomed senior class students who were attending the Board of Education meeting for their Government class, adding to let her know if they needed any clarification or had any questions at the end of the meeting.

Superintendent Ward stated that the board had invited the cast and crew of this year's musical, Music Man, to be recognized, adding cast had included students from Elementary through High School, noting she wanted to recognize not only those students who were on stage but those students who worked behind the scenes as well as the parents, staff members, and volunteers who also helped with the play. Mrs. Ward stated Music Man was a wonderful show, and took a lot of work.

High School Principal Matthew Frahm noted that most of the cast of the musical were probably across the street at Marching Band practice, adding a lot of time and energy went into the show and their performances were a real treat for the school and for the community, stating all of their hard work was greatly appreciated. Superintendent Ward stated that participating in the play is lot of time and energy, and along with keeping up with their school work and athletics it is a huge undertaking.

Mrs. Ward then introduced George Kotlik and Taylor King who participated in the Rotary Oratorical Contest on Ethics on Monday, April 15th at the Naples Rotary, explaining that each student writes their speech and presents it in regional competition with a chance to move on from there, adding George placed second in the finals at St. John Fisher College and won a scholarship. Mrs. Ward stated she had a chance to hear both speeches live at Rotary and they were awesome, adding Rotary members were also very impressed, and pleased to have them representing Naples, adding that the speeches are posted on the school website at http://www.naples.k12.ny.us in the news section. Mrs. Ward then thanked the students on a job well done. Taylor and George discussed their speeches and the writing process as well as developing presentation and public speaking skills. Board President William Kelly noted making a public presentation is a skill that will serve them well throughout their lives, adding that communicating is a tremendous tool and a key to success in whatever they may do, noting it takes a lot of courage to speak in public, and congratulating both of the students.

What does a School Resource Officer Provide?:

Board Member Michael Boggs introduced Marcus Whitman High School Principal Jennifer Taft and Marcus Whitman Central School Resource Officer Deputy John Peck. Deputy Peck and Mrs. Taft presented information pertaining to a School Resource Officer duties in a School District and the potential impact a School Resource Officer can have in the District. Board of Education discussion followed pertaining to information presented.

Administrative Reports:

Elementary Principal Kristina Saucke stated ELA testing had finished the week before and Math Assessments had started that day, noting the teachers were trying to make the testing experience as positive as possible, adding it is tough getting the students prepared for the tests and the teachers have done a great job. Ms. Saucke stated the Elementary is also gearing up for the end of the year rush, looking at schedules and class lists in preparation for next year, noting she feels the Elementary is at a good place.

Secondary Principal Matthew Frahm noted he had a Department Chairperson meeting on Monday which had started with a short You tube clip titled "Cowboys Herding Cats" adding that is what it feels like some days with testing, games, scheduling, prom, senior trip and all the other various activities happening at this time of year, noting he has a list of all the activities going on in April, May and June on his webpage, announcing the 5K race will be Saturday; the National Honor Society's Hike-a-Thon will be Sunday; Prom the following weekend; AP exams will be beginning soon; and Senior trip the week after that, stating this is a crazy time of year but also a very neat time of year.

Internal Claims Auditor Evelyn Letta stated that since the beginning of the school year, errors have been significantly reduced, however work still needs to be done as when the packet is sent to her it should be ready to sign and return rather than having to send the packet back for corrections which makes the process a little bit longer, so they are working on smoothing out that process, noting that overall they are doing very well.

Director of Pupil Services Alan Moore highlighted the Special Olympics competition to be held at Palmyra-Macedon on Friday, May 17th. Mr. Moore also noted he has been observing some excellent uses of technology in teaching our students of all ages, adding there are ipad assessments in the form of games, also ipads that can help with communication for non-verbal students.

Student Representative Randon Hoselton stated the Girls' Softball team was excited to announce that they won their game yesterday; the Boys' Baseball Team has a record of three wins and two losses, adding the team has high expectations of themselves, also noting the team members had purchased their own uniforms this year which was a nice way for them to help with extracurricular costs; the Boys Tennis Team has a record of three wins and one loss, adding the team is busy with four matches this week, noting he had watched one of their matches the day before and it was really fun to watch them play; Randon also spoke with a member of the Track Team, noting normally about four schools participate at each meet with the team members participating individually in the different events, noting that David Boise and Taylor Chapman have already qualified for sectionals; Academic All-Stars won the Large School Championship on Monday night; the Robotics Team has wrapped up their season for this year, noting the team made it to the semi-final competition at the Buckeye Regional and also received the Judges Award for Excellence, adding the team is a very hard-working group and have already had some meetings

to review and assess their year and to plan for projects over the summer and work on ways to improve in next year's round of challenges, announcing that one of their team members, Melissa Brautigam, was added to the FIRST Dean's List for exhibiting excellent leadership traits during the competition; the National Honor Society inducted sixteen new members from the eleventh and twelfth grades, announcing Elementary teacher Mr. Bay and High School teacher Mr. Robinson as the 2012-13 National Honor Society Teachers of the Year, also noting the National Honor Society is planning a Hike-a-Thon on Sunday to raise money for Honor Flight, a not-forprofit organization that flies veterans down to Washington, DC to see the various War Memorials; Randon stated he saw a performance of the school musical, Music Man, and he felt he got more than his money's worth, adding it was a lot of fun to see his friends on the stage performing something they had worked so hard on; Senior Prom will be May 4th at Bristol Mountain, noting the voting for Prom court had been completed, and the theme is the Enchanted Garden; there is a new club called the Produce Club headed by Mr. Fargnoli and Mrs. Radin-Snaith, noting the club had scheduled some planning that day after school and would be going to the Community Garden the next day for some planting; Randon discussed Mr. Wilde's Metals class, stating students have been working on various projects making tables, camp fire grills, hammers, and tool boxes out of different metals, noting as the students make the different items they are able to experiment with different techniques on how to design and build metal pieces, adding Mr. Wilde stated the class is reviewing for their final exam and are in the planning stages for a required C&C project; Randon noted the Construction Project has not had a major effect on activities in the High School as the project has been managed so that it is not interrupting the students' schedules, adding in general the project is being nicely run and is not obstructive to the learning experience.

Board Reports:

Facility Committee – Superintendent Ward noted the project is progressing well, stating the walls are getting taller, adding they have started the south-side wall for the pool; the plumbing is being finished up, including storm sewers, etc.; the school is preparing the gymnasium to be turned over to the contractors on Wednesday, May 1st, adding the District hopes to have the gymnasium back by October 1st; that night there would be a motion regarding approval for a change order for work on the ceiling in the gymnasium. Discussion followed pertaining to work on the gymnasium ceiling including some possible abatement of lead paint on the beams, noting everything is being done to keep costs down.

Policy Committee – Board Member Mona Sage-Cardinale stated the committee is looking forward to looking over the code of conduct which is currently being reviewed by the Shared Decision Making Team, adding the team has really been streamlining the code, making it more pertinent to Naples and our school environment. Ms. Sage-Cardinale stated they have also been discussing policies on Weapons in the School, Gun Free School Act, and Student Data Breach as well as other policies sent from Eris 1BOCES for review.
