## **Points of Interest:**

Board Member Margo Ulmer stated CNN and NBC had done an education focus with some interesting speakers, noting one of the discussions had been about two schools in New York City, a very rich school district and a poor inner city school district where the two principals worked together, agreeing on certain principals regarding student motivation and values to

develop a program called GRIT, working to reverse the idea that if you show up and participate you deserve a trophy, adding they wanted to teach their students that failure is a part of life and that as they fail at something they should turn that into a fundamental building block leading that will lead them to success.

Superintendent Ward stated a lot of what Mrs. Ulmer was talking about was included in the Carol Dwek book Mindset, noting a lot of the book deals with the fixed mindset vs. the growth mindset similar to what Mrs. Ulmer was discussing.

## **Superintendent Recognitions & Updates:**

Superintendent Ward welcomed back the secondary staff, thanking Teacher Aide Deborah Allison for attending, adding the secondary staff had a stressful start, noting when staff returned on August 29<sup>th</sup> they were unable to get into the building to work on their classrooms before the start of the new school year, adding the High School staff were unable to have access to internet including e-mail until just last week, commenting that it makes it very hard to get business done as usual. Mrs. Ward then thanked the staff for their patience, flexibility, resilience, and perseverance in dealing with the construction project.

Superintendent Ward then stated English Teacher Joelle Grifa had written a note of appreciation for the invitation to the Board of Education meeting recognizing the secondary staff.

Secondary Principal Matthew Frahm stated the High School staff has put in extra time weekends and evenings trying to get set for school after they were unable to have access to the building before the start of school.

Mr. Frahm then introduced the new foreign exchange student Tuvshin Erdenbaatar from Mongolia, who is staying with the Makepeace-Yerkovich family, noting Tuvshin arrived at the tail end of the summer, just before the beginning of the school year and is adjusting very well. 1st Vice President Michael Boggs asked how Tuvshin had chosen Naples. Tuvshin stated the exchange student program chose his location. Superintendent Ward asked what Tuvshin liked most about Naples. Tuvshin stated he liked the people, the environment and nature best. Board Member Ronald Burke asked what had been the best and worst things so far in High School. Tuvshin stated the worst thing had been to be studying again in High School as he had already graduated from school in Mongolia and the best thing has been living with the Makepeace's and the surrounding environment. Tuvshin stated he lived in the Capital city in Mongolia and what he missed most about Mongolia was his parents. The Board of Education then welcomed Tuvshin to Naples and Superintendent Ward thanked Tuvshin for attending the meeting.

Superintendent Ward sent out special Birthday wishes to Student Representative Randon Hoselton.

Vic Tomaselli of SEI Design Group and Todd LaBarr of Watchdog Building Partners then presented an update of the construction project, reporting they are coming to a close on Phase 2a

and hope to achieve substantial completion for Phase 2a by the end of October, noting they had been able to complete a good portion of the items from their completion list within the last week. Board Member Mona Sage-Cardinale asked if there had ever been a problem with the installation of the skylight. Mr. LaBarr stated there were never any problems with the skylight. Mr. LaBarr stated that pending State Education Department approval of Phase 2b they are looking being out to bid for Phase 2b in the month of October; accepting bids in the early part of November; and if the bidding process goes smoothly they should be able to begin work in the month of December over the holiday break, adding the first step in the construction process will be establishing the staging area and then demolition of the existing school structure.

Mr. Tomaselli stated they had hoped to have State Education Department approval by that day however they were waiting on the mechanical/electrical/plumbing plan reviewer's approval, noting the mechanical reviewer had been out for two and one-half weeks and so the plan was just reviewed at the end of last week and their mechanical engineers were currently responding to follow-up questions from the reviewer, adding they hope for approval in the early part of the next week and at that point they will be able to put Phase 2b out to bid.

Superintendent Ward stated she had received a call about a rumor that the school would be unable to feed the High School students in the fall of 2013, noting she wanted to reassure people that the food will be prepared at the Elementary building and brought over to the High School for the students until the new High School kitchen is up and running, hopefully by January of that school year.

Superintendent Ward stated she would like to do a kick-off of the Phase 2b project on December 5<sup>th</sup> with the students in the afternoon and then do a ground breaking with the kids and before the Board of Education meeting do tours of the building with refreshments honoring the completion of Phase 2a and the beginning of Phase 2b, asking the Board of Education members for ideas on how to make the celebration fit with Naples.

Board Member Joseph Callaghan requested information on the equipment chosen for treating the pool water. Mr. Tomaselli stated he would get information to the board regarding the pool's water treatment system.
