Superintendent Recognitions & Updates:

Superintendent Ward stated that Elementary Principal Alan Moore would be announcing the winners of the Dental Health Poster Contest, noting that the Dental Health Posters are still on

display in the front window at Vierhile's Furniture and Appliance Store, adding that she had witnessed her first Dental Health Poster Contest parade at Naples Rotary and it was very exciting.

Superintendent Ward then commended the participants in this year's musical, Annie Get Your Gun, stating the cast and crew had done an awesome job, and thanked them for all of their hard work.

Secondary Principal Matthew Frahm then asked members of the cast and crew who were in attendance at the Board of Education meeting, to stand and be recognized, stating he had read something by one of his favorite authors recently which stated that the best thing about the arts is that you only get better at them by doing them, practicing and rehearsing. Mr. Frahm stated Naples has busy students here, doing schoolwork, involved in Band, Robotics, athletics, etc, noting that the students involved in the play had spent a couple of months working a countless number of hours, dancing, singing, acting, and rehearsing, and put on three fantastic shows, bringing a tremendous amount of energy to the auditorium. Mr. Frahm stated the Musical Directors, Larisa Herley and Kathleen Goyette, along with Art teacher Paul Frazer who created the backdrops for the play, put in a tremendous amount of work and did a phenomenal job, giving a real gift to the community, thanking them for all of their efforts.

Superintendent Ward stated what impressed her most about the musical is that it is a District musical and seeing our young students as well as our older students and the time that they all invest in the musical, adding that it is great to discover the many hidden talents that come out on stage and to see that diverse group of students get along so well and present such a wonderful show, thanking all who participated.

Superintendent Ward stated that last year was the school's first opportunity to participate in the Chinese Language competition at Alfred University and this year we had the opportunity to have students go back to that competition. Secondary Principal Matt Frahm stated that there were three participants this year, Adrian Black, Jeanie-Marie Austin, and Skyler Yeatman, who take the Mandarin Chinese class from teacher Rebecca Fan of Alfred University, adding Rebecca

does a great job and is a real gift to our students. Mr. Frahm stated he was able to judge the students before they went to the competition at Alfred University, noting there is a speaking piece and a talent piece, adding it's pretty impressive to hear a group of students in Naples speaking Mandarin, displaying their different talents. Student Adrian Black stated he had the opportunity to travel to China last summer with the Confucius Institute and he chose to speak about his trip to China at the competition and for his talent he made Chinese Dumplings, adding the Judges had laughed when he made his dumplings. Adrian stated that Skyler had played the guitar and talked about how much he liked the Chinese culture and Jeanie had presented a poem she had written and translated into Mandarin. Adrian noted they had done well at the competition however it was intimidating to see how well the college students in their first year had done. Superintendent Ward stated she gave the students a lot of credit for representing Naples so well.

Elementary Principal Alan Moore announced he was very excited to have fourteen students, Dylan McMullen, Ben Fowler, Mason Martin, Grace Cerneskie, Madison Santillo, Stefan Radak, Autumn Kunes, Hannah DelGatto, Alison Moore, Sequoia Simons-Folts, Claire Radak, Tucker Steinmetz, Chloe Shearing and Nadia Pompeo, learning to play the Guhzeng (Chinese Zither) this year. Mr. Moore introduced Miss Daisy Wu Zhongbei, an Associate Professor of Music at Hunan University in China, on loan to the Confucius Institute at Alfred University, stating that Naples is lucky to have Daisy come to Naples once a week to work with our students on learning the Guzheng. Miss Zhongbei stated she was very proud of her students and loved them very much, adding that the students having been studying the Guzheng for five months and had had a very successful performance at Alfred University in April. Miss Zhongbai thanked the student's parents for their support in helping the students make such great progress, adding that she hopes the students will have more opportunities to perform in the future as it helps to keep the student's interest in learning. Some of the students presented a wonderful performance of a selection of songs on the guzhengs for those present.

Superintendent Ward introduced teachers Colleen Betrus (National Honor Society Advisor), Joelle Grifa (Junior High Student Council Advisor), Katie Johnson (Creative Arts & Year Book Club representative), and Katie Infantino (Elementary Student Council Advisor) who organized the Honor Flight Walk-a-thon on Saturday, April 9th. Mrs. Betrus explained that the Honor Flight program raises money and organizes trips for veterans to Washington, DC to see the memorials and monuments, adding that their fund-raiser was to raise money specifically for World War II Veterans, noting their goal had been to raise \$900 which would pay for two veterans' trips, however their group had raised over \$2,200 with approximately \$300 of that amount raised in the Elementary building through Penny Wars. Mrs. Betrus then announced that one student, Caitlin Taylor, had raised \$335 herself, almost enough to send one veteran, noting that Caitlin had dedicated her fund raising to honor her Grandfather who was a WWII veteran. Mrs. Betrus stated that the local veterans, including the VFW and the American Legion, participated in the event by doing the closing ceremonies at the end of the walk, giving a talk about the importance of some of the military symbols, also performing the song The Ragged Old Flag, adding they are very interested in pursuing something in the fall, and having our students help with another fund raiser for Honor Flight which Hank Raney will be in charge of. Mrs.

Betrus added that Bill Cooper had done an introductory presentation for the students to give them an idea of what Honor Flight was about, adding that Mr. Cooper had participated in the program by talking with the students about Honor Flight, which helped to generate interest among the students and really get them involved in the project. Mrs. Betrus added that she had received a phone call from Mr. Cooper that day saying that Naples Rotary, the Naples Historical Society, and one other local group had raised about \$2,000, noting that within the Naples Community alone, we are close to \$4,200 raised, which is very exciting.

Superintendent Ward thanked all of the participants, noting that the veterans were very proud of the students and appreciated everything the students had done.

Superintendent announced that the Green Machine would be coming to Naples Elementary school the next day, adding that Elementary Students would be engaged and excited about learning when they participate in a Crime Scene Investigation.

Mrs. Ward also reminded those present to participate in the annual St. J's 5K race, noting that the kids race would be at 4:00 pm on Friday afternoon, and the main race would be on Saturday, starting at 8:30 a.m. followed by the Cub Trophy awards ceremony when they would find out if the Secondary or Elementary received the most points, wishing everyone good luck with the race.

Superintendent Ward stated that after the presentation of the musical, Annie Get Your Gun, she felt it was a good time to brainstorm and discuss some of the needs for the our musical cast and crew and students to continue to have an environment to perform in and to reflect the hard work the students have put in, adding that Mr. Frahm had spent some time talking with Larisa Herley and Kathleen Goyette talking about the musical and what needs they might have in the future regarding sound or lighting, noting they have begun to investigate an improved sound system and/or lighting, and are looking at options available through fundraising and perhaps including items within the alternate options under the Phase II project, noting the hard work and hours that our students and staff put into not only the musical productions but also band and choral concerts.

Mrs. Ward updated the Board of Education regarding Senator Gallivan's visit to Naples Central School, stating that Senator Gallivan and his assistant Annie had spent almost two hours at Naples, taking a tour of the building and talking very specifically about our facility meetings, building aide and how important that is to our community, adding that Mr. Gallivan was very willing to spend as much time as needed here, and Mr. Gallivan had finished his visit by talking with Naples Teachers' Association representatives Dan Robinson and Kris Arsenault regarding issues important to the Naples Teachers' Association membership.

Board President Keith Swank stated Mr. Gallivan was very personable, adding it was good to make connections with people who have some influence on the purse strings in Albany.

Mrs. Ward stated she had attended the ribbon cutting ceremony at Senator Gallivan's new office in Canandaigua, the space having been donated for his use by Lynch Furniture, adding that Mr. Gallivan is a representative for Ontario, Livingston, Erie, and Wyoming Counties.

Reports:

Internal Claims Auditor Gretchen Pulver stated it was a short report even though she had audited many, many claims, stating that she felt they were all doing a great job, adding they were now working on reviewing the utilities to ensure they are only paying for the things they are using, noting that overall she was very pleased with how everything is running, and everyone is working hard to get everything through the system as quickly as possible.

Director of Pupil Personnel Kristina Saucke commented that they had had an administrative Team meeting, discussing their goals to take care of during the remainder of the year, noting how little time there was until the school year would be over. Ms. Saucke highlighted that she and Elementary Principal Alan Moore would be taking the time to do some reflection and review with each of the departments at the Elementary school to discuss if there were things they need to fine tune, change, or add to for the upcoming school year and to start the task of getting suggestions for class lists for next year. Ms. Saucke stated it is really crunch time for the Committee on Special Education & Committee on Preschool Special Education, adding they have additional reviews to do as birth date annual reviews for students born in the summer must be done now; students who attend out of district programs are reviewed; and preschool students who are transitioning into kindergarten have to have an annual review and then a separate meeting for a transition to the committee for school age education. Ms. Saucke stated she appreciates the support from the teachers and from the team at this time of year as there is a lot of planning to complete.

Elementary Principal Alan Moore stated the Green Machine, which is a Crime Scene Investigation Van, would be coming to Naples Elementary and all of the sixth grade students would get to participate in the program, adding the students would have to use scientific skills to solve a crime by the end of the day. Mr. Moore stated he felt it would be very engaging for the students, and invited the board members to stop by to see the Green Machine, noting the answer would be revealed at 1:15 p.m. Mrs. Ward thanked teacher Abby Castle for working very hard to arrange to bring the Green Machine to the Elementary school tomorrow, adding the program was covered by Arts in Education funding.

Secondary Principal Matthew Frahm stated he and teacher Mary Phillips had attended a conference in Albany led by Giselle Martine-Kniep, titled "Leading Schools towards Continuous Improvement", noting Ms. Martine-Kniep had talked about that with all of the challenges that we face in education today there seems to be no shortage of initiatives, adding that everybody seems to have an idea about how to fix education and increase academic achievement, also talking a lot about the importance of having alignment. Mr. Frahm noted that as he and Mrs. Phillips were driving back to Naples and reflecting on the conference it was nice to think about how Naples is already making sure programs such as RTTT, Common Core Standards, CDEP, board goals, and school goals are aligned through Board of Education support and strong leadership within the District, noting that if you are at a board meeting, a department meeting, or a conference you are hearing those things again and again and they are tied together, commenting that those things do not happen by accident and he thinks the school is on the right path.

Student Representative Eric Cotton stated that girls and boys varsity teams will have to make up fifteen games due to the constant rain; the musical went very well, noting that they had done a very impressive job; Academic All Stars won the Large School Championships against Corning West, announcing that it was very exciting and the team had received a Fire Department escort

into town; the Honor Flight and the ARC Game night, both organized through National Honor Society, went well, adding that it was very nice to be a part of the ARC Game night and see how the participants' faces lit up as soon as they started playing games, noting it was a very fulfilling event; AP tests are coming up next week; Senioritis is kicking in for the seniors with only thirtytwo days left of school.
