Public Comment:

Operation Santa advisor Deborah Allison introduced student Operation Santa Committee members Joseph Kickbush and Erin Halladay, and thanked all those who have been supportive of Operation Santa this year.

Students Joseph Kickbush and Erin Halladay gave an overview of Operation Santa stating:

17 students participated in Operation Santa this year

Students signed 400 donation letters and 150 Holiday Cards to be sent out.

The 2009 Operation Santa fund raising goal was to raise \$14,512 adding they are currently \$1,000 short of their goal however donations usually continue to come in throughout January and they are hoping to be able to reach their goal.

Committee members begin work in late October, adding students dedicate over 75 hours to Operation Santa, including after school hours, work over Thanksgiving break and several late nights with work extending into February with at least one day during February break being used for Operation Santa.

Erin stated that additionally students of Mrs. Herman's classes worked after school to make ornaments to be give to families and senior citizens, adding they also wrapped over 100 fruit baskets.

Operation Santa gave to 63 needy families in the Naples School District, approximately 145 children received gifts of clothing, toys, games and books.

140 fruit baskets were distributed to families and senior citizens, over 60 senior citizens received fruit and candy baskets, and fruit baskets also went to Hospeace House, Thompson Nursing Home and an extended care home here in Naples.

Over 95 bags of gifts were delivered by Naples Rotarians, adding these were not small holiday gift bags but large 33 gallon size bags.

Operation Santa Advisor Deborah Allison stated this is no small task that these students undertake, adding she starts recruiting in October, the adult committee starts in September, adding the students who are a part of Operation Santa give up much of their time as well as the opportunity to participate in winter activities such as skiing, swimming, or bowling as Operation Santa takes place directly after school, the same time as a sport would run their practice or their meets, stating the students also show up during their free periods or lunch time during the school day. Ms. Allison commended the student participants for their commitment to Operation Santa, adding next year will be the 70th year of this Naples tradition and she would like to hear from all those who have been a part of Operation Santa throughout the years.

Superintendent Ward stated she had witnessed the hard work and dedication of the Operation Santa volunteers, thanking Deborah Allison for her leadership of Operation Santa. Board Member Michael Boggs stated he had had the opportunity to see the students and Ms. Allison at work while giving a tour of the building for the Citizen based committee, adding Operation Santa is a wonderful program.

Physics teacher Patrick Freivald announced the Robotics Kick-off would be Saturday, January 9th at the Theater on the Ridge, with a broadcast on national TV starting at 10 am on the NASA channel. Mr. Freivald stated there are about 30 students participating in the Robotics program this year, approximately 10 % of the student body of 7th-12th grade students.

Superintendent Updates:

Auditorium Seating: Superintendent Ward announced that Penn Yan school district has offered to donate their auditorium seating as their school is renovating, adding the seating will be available for our staff to remove and install at NCS by January 15th. After discussion by the board, it was decided that the school would use only the number of seats we can currently use plus a few extra for possible replacement in the future.

Senior Citizen Exemption: Superintendent Ward asked School Business Administrator Ann O'Brien to present information pertaining to the Senior Citizen exemption. Ms. O'Brien stated after reviewing the school's senior citizen exemption level, she recommended the Board of Education approve an increase, adding an increase in the minimum tax for senior citizens would result in an approximately 5 cent increase in tax bills.

China Trip: Director of Curriculum and Instruction Lynn Strang thanked the Board of Education for the opportunity to travel to Beijing, adding while in China she was able to tour schools and meeting with Chinese educators and colleagues from around the United States. Mrs. Strang stated Naples has been very blessed to have the opportunity with the Confucius partnership through Alfred University, adding our students will be working more and more with the Chinese. Mrs. Strang stated the program is to develop a partnership in learning with Chinese educators, noting the differences in Chinese and American schools, and also differences in teaching styles between Chinese educators and those in the United States.

Lock Box: School Business Administrator Ann O'Brien presented information pertaining to the proposed use of a lock box vs. a full time tax collector. Ms. O'Brien stated the lock box would be located at the Community Bank, rather than Five Star, adding the individual would not receive a formal receipt until after the their payment is processed by Chase Bank. Ms. Obrien stated the school would save approximately 45% of the current cost of tax collection. Superintendent Ward noted the first year would be tough however after the first year the process would become routine, adding it would increase efficiency at tax time. Mrs. Ward stated the school would hold public meetings to inform residents of the new collection process. Board discussion followed pertaining to the information presented with a general board consensus that the school should proceed with the change to using a lock box.

Superintendent Ward updated the board on the Governor's decision to withhold approximately \$226,000 in State Aid along with Star payments, adding the school has received conflicting information as to whether this will be a delay or a default in payment, adding the school would like to really limit spending over the next few months, which will help us prepare for next year's budget in terms of fund balance and making sure we are putting out a budget that is fiscally responsible to our tax payers. Board Member Judy DiRaddo stated she feels an important part of our planning is to hear from the administrators as to the proposed curriculum and fiscal plans for next year through three years down the road. Superintendent Ward stated the Comprehensive District Plan is being developed , adding our school has a commitment to continue the tradition that we have to be a school district that is academically highly successful but at the same time fiscally responsible to the taxpayers. Discussion followed pertaining to current and proposed budgets and different processes followed by the district in conducting its day-to-day business.

Facility Committee Report: Board Member Michael Boggs stated their last meeting was on 12/21/09 and the next meeting will be held on Monday, January 11th when they will be touring the Elementary School and Bus Garage, stating the value of touring the facilities is to give people an opportunity to see the interior of the school and provide the board members with feedback as to what the community feels the board needs to attend to. Mr. Boggs stated they would be putting together a timeline to establish what needs to be accomplished by when so the committee can determine when the Phase II project can go out for a vote.

Policy Committee member Gail Musnicki stated the 1st reading of the Return Check Policy would be voted on adding at their next meeting, the committee will continue to discuss staff use of Computerized resources and the Medicaid compliance program policy.

Superintendent Ward stated she hopes to bring together the Curriculum committee as soon as the Comprehensive District Plan is complete allowing the committee to review the plan allowing us to

have a real focus as to what our priorities and initiatives will be in terms of Curriculum & Instruction and improving academic achievement throughout the district.

Board Member Mona Sage-Cardinale stated the Shared Decision Making team is comprised of parents, administrators, teachers, para-professionals, who are all working together to complete the Comprehensive District Plan which is mandated by the State of New York.

Superintendent Ward stated she and Board President Keith Swank had attended the NYSSBA workshop on negotiation strategies which was very informative, including self-evaluation forms for the board and administration.

Mrs. Ward stated over break the administrators came in and completed their strategic plans, identifying their strategies and priorities, adding how nice it was to see that the Administrative focus and the Board of Education focus are very similar. Superintendent Ward discussed the strategic plan in the area of Citizenship, stating the board had defined the strategy as we believe in supporting excellence in teaching and providing a balance of activities that motivates individual students to become life-long learners and contributing members of society. Discussion followed pertaining to their thoughts in the area of citizenship. Board Member Judy DiRaddo suggested requiring volunteer activity for graduation, stating a number of schools in the area have volunteer service as a requirement for graduation. The board agreed to explore a community service requirement. Board Member Margo Ulmer stated at one time it was a part of the Senior Government course with 10% of the grade based on the number of hours of service and the quality of work. Superintendent Ward asked the administrators to talk with colleagues regarding programs in other districts and come back to the board with their recommendations. Discussion followed pertaining to the suggestion. Board Member Gail Musnicki stated anytime we can encourage our students to be better human beings is great. Board Member Michael Boggs stated a peer recognition award, stating peer recognition often has a greater impact. Board Member Mona Sage-Cardinale stated anything that makes the students love and appreciate each other and their school is going to be a benefit. Superintendent Ward stated anything to do with school spirit, adding sportsmanship is key and at each game spectators look for good sportsmanship in our students. Board Member Judy DiRaddo stated she had attended a conference on peer mediation and elementary students being involved in leading their own parent-teacher conferences.

2. Said special meeting shall be called by giving the following notice thereof:

NOTICE IS HEREBY GIVEN that a special meeting of the qualified voters of the Naples Central School District shall be held at High School Library in said District, on Thursday, February 25, 2010, between the hours of 12:00 p.m. to 9:00 p.m. The following proposition will be submitted for voter approval at said meeting:

PROPOSITION

Shall the following resolution be adopted to wit:

RESOLVED THAT THE BOARD OF EDUCATION OF THE NAPLES CENTRAL SCHOOL DISTRICT IS HEREBY AUTHORIZED TO UNDERTAKE THE ACQUISITION OF TWO (2) 71-PASSENGER SCHOOL BUSES, AT AN ESTIMATED MAXIMUM AGGREGATE COST OF \$207,500; AND ONE SUBURBAN AT AN ESTIMATED MAXIMUM COST OF \$37,500, ALL AT AN ESTIMATED MAXIMUM AGGREGATE COST OF \$245,000; AND THAT SUCH SUM SO MUCH THEREOF AS MAY BE NECESSARY, SHALL BE RAISED BY THE LEVY OF A TAX TO BE COLLECTED IN ANNUAL INSTALLMENTS, WITH SUCH TAX TO BE PARTIALLY OFFSET BY STATE AID AVAILABLE THEREFOR; AND, IN ANTICIPATION OF SUCH TAX, DEBT OBLIGATIONS OF THE SCHOOL DISTRICT AS MAY BE NECESSARY NOT TO EXCEED SUCH ESTIMATED MAXIMUM AGGREGATE COST SHALL BE ISSUED, OR THE SCHOOL DISTRICT MAY ENTER INTO AN INSTALLMENT PURCHASE CONTRACT IF THE BOARD OF EDUCATION DETERMINES THAT IT IS IN THE BEST INTEREST OF THE SCHOOL DISTRICT TO FINANCE THE PURCHASE IN THAT METHOD.

AND NOTICE IS ALSO GIVEN that applications for absentee ballots to vote on the propositions may be applied for at the office of the School District Clerk. Any such application must be received by the District Clerk at least seven days before the date of the aforesaid special district meeting if the ballot is to be mailed to the voter, or the day before such special district meeting if the ballot is to be delivered personally to the voter. A list of all persons to whom absentee ballots shall have been issued shall be available for public inspection in the office of the District Clerk during regular office hours on each of the five days prior to the day of the vote (excluding Saturday and Sunday). An absentee ballot must reach the office of the District Clerk not later than 5:00 p.m. on the day of such special district meeting.

School Business Administrator Ann O'Brien presented information pertaining to the formation of a Capital Reserve Fund, explaining that the intent of this fund would be to put money away for the purpose of building maintenance and future improvements with funding for the fund to come from undesignated revenue, for example if the school is planning to complete a project such as replacing a roof then the school can put money away for that project in this fund. Ms. O'Brien emphasized the money put into this fund would not come from increases to taxpayers. Board Member Barbara Howard stated this fund would allow the school to set money aside, allowing the school to start saving for building projects rather than having to go out for a separate bond funded proposition each time the school needs to do work. Board Member Joseph Callaghan stated if the school had committed to saving for projects with a fund such as this 10-15 years ago it would be in a much better position.

BE IT RESOLVED, by the Board of Education of the Naples Central School District, New York, as follows:

Section 1. Pursuant to Section 3651 of the Education Law there is hereby established a capital reserve fund for the Naples Central School District, New York, which shall be designated as the "Building Capital Reserve Fund" of said School District.

Section 2. Such Building Capital Reserve Fund is hereby established for financing, in whole or in part, the following objects or purposes of said School District:

Site Work, addition to, reconstruction and equipping of, school buildings and facilities, and costs incidental thereto.

Section 3. The ultimate amount of such Fund shall be \$2,000,000 plus earnings thereon.

Section 4. The probable term of such Fund shall be ten (10) years, after which time no further funds may be transferred to such Fund, unless previously extended by the voters, but such Fund shall continue in existence until liquidated in accordance with the Education Law or until the funds are exhausted.

Section 5. The source from which the funds for such Fund will be obtained is as follows:

- (i) amounts from budgetary appropriations from time to time, and
- (ii) unappropriated fund balance made available by the Board of Education from time to time, and
- (iii) New York State Aid received and made available by the Board of Education from time to time, all to the extent permitted by law.

Section 6. This resolution shall take effect upon the approval thereof by a majority of the qualified voters of said School District voting on a proposition therefor submitted at the annual or a special district meeting of said School District, the details of which shall be specified by a further resolution of this Board of Education. Upon such approval, no further action of this Board of Education will be required to perfect the establishment of such Reserve Fund.

Section 7. The form of this proposition to be so submitted shall be substantially as follows:

PROPOSITION # 2

Shall the following resolution be adopted to wit:

Resolved that the Board of Education of the Naples Central School District is hereby authorized to establish a Capital Reserve Fund pursuant to Section 3651 of the Education Law (to be known as the "Building Capital Reserve Fund"), with the purpose of such fund being to finance site work, addition to, reconstruction and equipping of, school buildings and facilities, and costs incidental thereto, the ultimate amount of such fund to be \$ 2,000,000, plus earnings thereon, the probable term of such fund to be 10 years, but such shall continue in existence until liquidated in accordance with the Education Law or until the funds are exhausted and the sources from which the funds shall be obtained for such
