Board President Keith Swank read an update on the Naples Central School District Superintendent search into the board minutes. (Attached)

Board member Margo Ulmer read the report and recommendations of the designated Ad Hoc Committee on Grade Weighting at the Secondary School in to the board minutes. (Attached) The Ad Hoc Committee recommended that Advanced Placement courses be weighted at a 10% increment and Dual Credit courses be weighted at a 5% increment for purposes of establishing class rank and that the Policy Manual be revised by the committee to reflect this policy clarification.

Interim Superintendent Gerald Macaluso stated he would prepare a modified board policy reflecting the recommendations of the committee, adding there will be three readings of the modified board policy: February 4, 2009, March 11, 2009, and March 25, 2009. Mr. Macaluso explained that the Board of Education must approve the revised policy at each reading for approval of the policy, adding if the revised policy is defeated at the 1st or 2nd reading then the original policy as written stays in effect. Mr. Macaluso commended the administrative staff, teachers, board members and students who worked together to examine the policy and recommend changes.
