### Pledge of Allegiance

#### **Public Comment:**

Board President Jacob Hall noted that Boy Scout Troop 40 was present at the meeting. Boy Scout member Aaron Hall explained that in order to earn their badge for Citizenship and Community they needed to attend a city council or board meeting of some sort and they had chosen to attend the Naples Central School Board of Education meeting.

#### **Points of Interest:**

Board Member Angela Rischpater noted we had our first snow today.

### Superintendent Recognitions & Updates:

Student Representative Update – Student Representative Garett Waltman stated they had their last cross-country meet, noting they had done pretty well, adding a number of the team members had run their personal bests; Operation Santa recently started up, adding members have started writing thank you letters to donors and they will be starting to shop in the next couple of weeks; National Honor Society is planning a canned food drive which will start in the next couple of weeks to support Naples Open Cupboard, and a pie baking contest among the teachers after which they will be selling the pies with proceeds going to the Naples Open Cupboard.

Superintendent Update – Superintendent Kevin Swartz stated he appreciates the varied things that our staff does, noting the Elementary School had a number of presentations on student safety yesterday including a presentation from our Director of Transportation Pat Elwell on Fire Safety; High School biology teacher Jon Betrus presented on outdoor safety and firearm safety; and School Resource Officer Durgan presented a talk on Halloween safety, adding our staff are always willing to do things that are not in their job description but are good for kids.

Superintendent Swartz touched on the questions regarding the increase in ticket prices charged by Section V for sectional games, noting the price is currently around \$7.30/person, making it expensive for families to attend sectional games, adding depending on what sport the kids are competing in, spectators may be charged every contest you go to right from the beginning through sectionals while others you may not be charged until you reach the semi-final or state rounds, noting there are a lot of inconsistencies and it can be a lot of money for a family. Mr. Swartz added there is a school district in our region, who rather than charging folks at the gate, made a head count of people attending and paid Section V for those attending the game; noting they should not have the option to do that and are asking Section V to take a good hard look at how much they are charging families, and to look at ways to make it more affordable for families. Superintendent Swartz stated we cannot include that cost in our expenditures as it is not a part of the budget as approved at the annual vote, noting Section V did put a statement out clarifying why they charge and that this is how they raise their money. Athletic Director Adam Robison stated it was a major topic at the regional Athletic Director's meeting.

#### Administrative Update

Director of Student Learning, Curriculum, and Assessment Lindsey Evershed-Pursel stated Ellen Ellison, a middle school Science teacher, was able to present at the National Science Teacher Association in Kansas this past weekend, noting her presentation was all about how to get kids really connected to Science and doing it in a more personalized way called localized phenomenon, for example creating a topographical map of our area or looking at fossils from Grimes Glen, adding it was phenomenal to see one of our teachers in a leadership in learning position. Mrs. Pursel stated not only did Ms. Ellison do her presentation, she also brought back a lot of great information to share with the Science Department as we move forward with the new Science standards from NYS.; They have had some great curriculum discussions at both the High School and the Elementary School, noting she has received a lot of great feedback, adding Assistant Secondary Principal Heather Clark, Director of Technology Ben Pursell and she have been working very closely with WFL BOCES and vendors to get our data dashboards up and running, adding they hope it will be ready by the end of the month.

Board President Jacob Hall stated there is a really neat 3-D map of Naples in the old Town Hall, adding perhaps Megan Bay would be able to help them view it.

Board Member Steven Mark asked how Science teacher Ellen Ellison was asked to present at the National Science Teacher Association. Mrs. Pursel stated that Ellen was one of the lead researchers on this work through the University of Rochester and U of R had covered all of her travel costs to the conference.

- Secondary Principal Matt Mahoney stated he continues to be impressed by students and staff at Naples Central School, adding the students are well-rounded, noting a number of students will be performing at All-County; the athletic teams have done very well this season; the student involvement with Red Ribbon week; the Blood Drive; adding there is always something going on within the school that the kids are involved in that is a benefit to the students and/or community. Mr. Mahoney stated he has had the opportunity to start classroom observations and its great to see teachers bringing learning alive to students in the classroom, noting there are some really great opportunities for the kids.
- Elementary Principal Kristina A. Saucke stated they are in full swing with the Math Pilot Program, noting all grade levels are piloting one unit from a program called Eureka Math<sup>2</sup>, noting they are trying to determine if they want to move forward with the program, adding they are excited to see where that goes; Ms. Saucke stated she has begun observations as well; they have just had a family move in from Guatemala with an Elementary student who does not speak English, noting the student is acclimating well; Starting to dig into some reports on specific regional instruction results from the state; Social Emotional Learning and Character Education Program covered student safety, especially around Halloween, noting it was Deputy Durgan's birthday as well; Jon Betrus and members of the Trap Shooting Team presented; the local Fire Department, the Ambulance and Pat Elwell; the traditional Halloween Parade: the After School Program is in full swing and is going very well, commending Pat Elwell and Joanne Schenk for all of their work in arranging transportation for the students, noting the first session will end on the 16th and they will be looking for interest in the 2<sup>nd</sup> session which will start after the holidays; They continue to meet weekly for Capital Project updates with the Construction Manager Ryan, Director of Facilities Shawn Mason, Naples Teachers' Association President Chris Arsenault and herself, adding things continue to go smoothly, and they are very excited for the new playground to be completed; Ms. Saucke commended the Parent Teacher Partnership, noting they are in the midst of ordering new school shirts for the students, adding the PTP did a cider and donut sale as a fund raiser for money to cover the cost of field trips; Monday the 13th will be the annual Veteran's Day Rally in the Valley, noting they have sent information out to invite veterans to attend, adding the High School Chorus and Band will also be part of the activities. Discussion followed pertaining to information presented.

### Athletic Director Update

Athletic Director Adam Robison stated Modified Girls Soccer had an undefeated season with four shut-out games, adding they had updated the kickboard at the High School field;

Varsity Girls Soccer Advanced to the Sectional Quarterfinals with a league record of 7-0, overall 16-2, with 1st Team All-Stars Abby Hall, Polly Bay and Bella Fowler, 2nd Team All-Stars Kendra Hulbert, Mia Betrus, Grace Hebding, and Sadie Gursslin, as well as Honorable Mentions Juliann

Hall and Kiera Mackenzie, adding Grace Hebding moved to #6 on the Naples career shutout list and Eliza Almekinder was FLW Player of the Year and will be recognized tomorrow at the Section V banquet;

Modified Boys Soccer ended the season at 8-1-2, noting coach Lincoln did a phenomenal job of focusing their energy, adding the team's one loss was a result of the coach choosing to enforce consequences for the kids who were not choosing to do the right thing, commending Coach Lincoln for his actions;

JV Boys Soccer had an undefeated season with a goal differential of 76-7, noting that every player on the team scored at least one goal this season;

Varsity Boys Soccer had a 16-0 season with a goal differential of 79-8, adding the team advanced to the Section V Class District Finals where they last 2-1 to Fillmore in overtime. 1st Team All-Stars were Matt Lincoln, Evan Rischpater, Landon Gleichauf, and Jake Betrus, 2nd Team were Traugott Uhlen, Oscar Austin, and Isaac Ward, Honorable Mentions were CJ Fuller and Lukas Hall, with Class District Sectional All-Stars being Matt Lincoln, Landon Gleichauf and Jake Betrus and Exceptional Senior Representatives Traugott Uhlen, Ian Kenney, Devon Ward and Cotton Burke.

Mr. Robinson noted a point of emphasis at all of his Athletic Director meeting has been the number of player disqualifications that have been taking place throughout Section V, noting there have been more disqualifications in the first three weeks of the year, than the entire sports season last year, however Naples has had Zero disqualifications or cards for players or fans, adding Coach Betrus received comments from other coaches and referees on what a beautiful game we played all year, a true sign of some wonderful young men, then sharing an email he had received from a spectator complimenting our team and head coach on their polite and courteous behavior and wishing them good luck for the remainder of the season;

Varsity Golf received a League Record of 9-3 and Overall Record of 12-3, with 1<sup>st</sup> Team All-Star Matt Lincoln and 2<sup>nd</sup> Team All-Stars Donovan Lincoln, Landon Gleichauf, and Grady Grove, with Matt Lincoln, Grady Grove, Landon Gleichauf, Donovan Lincoln, Maddox Mannella and Rowan Biggs included in the Finger Lakes League Championship Qualifiers Top 40 Golfers, noting five of those students are dual sport athletes;

Cross Country Team had 23 runners earn a PB at the League Championship Race with Erica Reigelsperger placing 2<sup>nd</sup> overall and Jude Rischpater placing 3<sup>rd</sup> overall; 1<sup>st</sup> Team All-Stars were Jude Rischpater and Erica Reigelsperger; The Top 7 (with two alternates) will travel to Letchworth this Saturday for Sectionals with the Girls Class District Race starting at 9:45 a.m. and the Boys Class District Race starting at 11:45 a.m., adding the Top 5 from each race will advance to the State competition on November 11<sup>th</sup>.

Athletic Director Robison stated the modified teams have started practicing for the winter sports.

There are some new members in the Naples Sports Boosters who are looking to make a few changes in how they run things, noting they are starting a speaker series and their first speaker will be Clarke Brown who will be coming in during 9<sup>th</sup> period to talk with our athletes about nutrition, adding they are looking for other speakers who will start coming in at the start of each season on topics such as injury prevention and off-season training.

November 1, 2023 Regular Meeting

Mr. Robison stated they will be working on sportsmanship at Basketball Games, noting coaches will be emphasizing this when they meet with parents as well, noting this is a league wide project, adding at the regional Athletic Director meeting they are working on a pre-game speech to give to everyone in attendance at the games, stating Section V is taking this seriously and if fans are not adhering to the rules they will have to leave the game and they will have to participate in a sportsmanship course before they are allowed to come back.

Discussion followed pertaining to information presented.

### **Board Reports:**

#### Facilities Committee

Superintendent Kevin Swartz stated the framing of the Elementary classrooms in nearly done with about 90% of the work completed; the mechanical and electrical work are progressing well; the High School auditorium abatement is now complete and the stage is now out; they did some significant work moving the gas line this past weekend, extending his appreciation to Shawn Mason and his crew for all of the preparation work leading up to that weekend; next steps in the auditorium will be the floor demolition; As of yesterday morning all of the playground equipment is at the Elementary School and should be installed by the end of November; The signs are being proofed for the playground as well; The Capital Outlay project on the panels at the Elementary should be completed by mid-November; Staffing for the Maintenance Department continues to be needed; SEI will be completing the 2024 Building Condition Survey required by NYS this spring, adding the survey will help us set priorities for the next Capital Project which we are hoping will include athletic fields.

School Business Administrator Chad Hunt stated our Construction Management Company, LeChase, has been a breath of fresh air to work with on this project, and Ryan Volare, the project manager has been very responsive and super proactive, and very sensitive to the fact that he is working in an instructional environment, stressing how great they have been, adding Mike Hoag has also been great but he will be retiring at the end of November. Mr. Hunt also announced Vic Tomaselli from SEI will also be retiring, noting he has been tremendous to work with.

The Naples Central School District (hereinafter referred to as the "District") and the CSEA, Inc. (hereinafter referred to as the "CSEA"), (collectively referred to as the "Parties") are parties to a collective bargaining 2019-2027 Agreement (hereinafter referred to as the "CBA") and recognize:

- 1. Appendix A of the CBA states that the entry range for 2023-27 "Part-Time Laborer" is between minimum wage \$16.20 hourly;
- 2. The District wishes to hire a full-time Laborer; and
- 3. The Parties wish to resolve this matter amicably and in the best interest of the CSEA and the District.

Therefore, the Parties agree as follows:

- 1. To amend Appendix A of the CBA to state that the entry range for 2023-27 "Part-Time or Full-Time Laborer" is between minimum wage \$16.20 hourly
- 2. This change will be incorporated into the successor agreement to the 2019-2027 CBA.
- 3. The parties hereby acknowledge that they had the opportunity to be advised by counsel or Labor Relations Specialist, and/or CSEA Unit President regarding this Agreement, that they have read this Agreement, that they fully understand its contents, and that they have executed the same and made the agreement provided for herein voluntarily and of their own free will.
- 4. By their signature below, the parties acknowledge the above understanding is being made based on the particular circumstances involved and that this agreement shall not serve as a precedent in any future application or interpretation of the collectively bargained agreement between the parties, except as stated therein.
