Public Comments – Boards Response – There were no public comments.

#### **Points of Interest**

- The BOE Meeting of February 26<sup>th</sup> is cancelled.
- The Board Retreat is scheduled for February 26, 2025.
- Board Member Amie Levine shared that boys took 1<sup>st</sup> place and the girls took 3<sup>rd</sup> place in the Alpine Skiing Sectionals at Hunt Hollow Ski Club.
- Board Member Steve Mark thanked Board President Jacob Hall for touring the school visiting classrooms. Mr. Hall said it was an awesome opportunity and a great reminder of how awesome our kids and staff are. He elaborated on what he saw from vertical alignment

of the literacy program, resources being maximized and seeing student engagement in the many classrooms that he visited.

#### **Superintendent Reports – Administrative Reports – Presentations**

<u>Transportation Supervisor Update:</u> Patrick Elwell shared detailed data regarding EV Buses and their battery usage comparing the months of April 2024 and January 2025 with variable temperatures. Mr. Elwell shared that the drivers and students like the buses and that operational, they have been doing well. Mr. Elwell shared that the cold weather has some challenges and that he is working with the engineers on these struggles. Details were shared and how he was able to work around this. Mr. Elwell also shared his concerns and hopes that the information will be reviewed at a state level.

Superintendent Swartz shared that there was a Superintendent's meeting that was held in the Transportation Conference room recently where area superintendents were in attendance. A similar presentation was shared with the group by Mr. Elwell. The BOCES Superintendent, Lynne Rutnik, shared with Mr. Swartz that she would like to look into having the information be presented at a future conference in front of the state. Mr. Swartz thanked Mr. Elwell for his work in keeping the data and the usefulness of it. Board Member Jacob Hall along with the rest of the board, thanked Mr. Elwell for his leadership and all he is doing.

Student Representative Update: Abigail Hall shared that the winter sports are coming to an end and shared information on the Alpine Ski Team, Bowling Team and the Trap Shooting Team. She also added that the exchange students really enjoyed the snow day as they don't get to experience that.

<u>Superintendent Update:</u> Superintendent Kevin Swartz congratulated both the ski teams. He also congratulated the eleven students who were inducted into the National Honor Society.

Mr. Swartz provided an update on the auditorium progress. During the last 48 hours, the progress has really taken off. The seats went in and really looks great. Completion is expected late February, early March.

Mr. Swartz updated the board on Regionalization – sharing of resources in our region. Mr. Swartz has had conversations with Honeoye CSD and Bloomfield CSD superintendents and is planning on meeting over the February break to further those conversations on sharing resources.

Mr. Swartz met with Student Council and talked with them about the Naples Logo. He asked the students if there was an interest in adopting the new logo. He explained that there is no intent to change the logo, name or create a brand-new mascot. We are the Big Green Machine and there is history with the tank. Mr. Swartz will be following up with Student Council to help facilitate a survey to the students.

<u>Budget Workshop #2:</u> Assistant Superintendent for Business, Chad Hunt, presented Budget Workshop #2. He shared that there are not a lot of changes. However, some items were adjusted after meeting with some departments. The gap is a little bit bigger and he is working through that. No changes with State Aide Projections or the Reserve Usage. Currently working through the budget deficit and the expenditures are more than the revenues. Budget highlights: The Tax Cap is at 2.57% and the Budget-to-Budget *estimated* increase is at 3.5%.

Board Member Maura Sullivan provided an update from the committee. The committee is continuing to go through all the policies and she noted that the committee is at 510 of 661 pages of the policy. The committee reviewed policy numbers 7411 through 7540. The committee is considering the removal of policy 7445, Student Voter Registration and Pre-Registration, as this is not a required policy. There were recommendations to update the language in policy 7450 and 7540.

If our opinion on the financial statements or the Single Audit compliance opinion is other than unqualified, we will fully discuss the reasons with you in advance. If, for any reason, we are unable to complete the audit or are unable to form or have not formed an opinion, we may decline to express an opinion or to issue a report as a result of this engagement.

#### REPORTING REQUIREMENTS

The following reports will be submitted to BOCES as part of the overall reporting package:

- The Minimum Audit schedules for a Board of Cooperative Educational Services or School District as issued by the New York State Education Department.
- An audit opinion with accompanying financial statements and notes for all funds and account groups of BOCES or School District.
- An audit opinion with accompanying financial statements and notes for the Extra classroom Activity Funds.
- An audit opinion with accompanying financial statements and notes for Single Audit programs.
- A management letter, which will include a summation statement of audit findings, a description of any material weaknesses in internal control, and recommendations for financial management improvement.
- Annual presentation of the above to BOCES or School District's Board of Education and Audit Committee at a regularly scheduled public meeting.

#### APPROACH AND METHODOLOGY

Our audit methodology is based on a comprehensive audit program developed utilizing industry audit guides and professional reference material primarily from CCH. Our work plan includes a detailed study of your internal controls, testing of transactions, analytical analysis and substantive procedures as required. In planning and assessing risk, the audit will require that we review and understand such things as your budget, organizational charts, financial reporting and your computer system.

#### **COMPUTER APPLICATION**

#### ANALYTICAL PROCEDURES

Analytical procedures will be used in the planning stage, as a substantive procedure and in the final review stage of the audit.

#### INTERNAL CONTROLS

Our approach to gain an understanding of your internal control structure will include questionnaires, flow charts, interviews with employees and testing of transactions. Our audit program has a series of procedures required to be completed that specifically address laws and regulations that will be subject to audit testing. Our audit sample includes target testing which is for the purpose of compliance.

#### **EMERGING ISSUES**

The Governmental Accounting Standards Board has issued an exposure draft titled the Financial Reporting Model Improvements. The objective of this proposal would be to improve the effectiveness of the Financial Statements in providing certain information to its users. Districts and BOCES will need to begin to prepare for this change and will need to educate their board members on the impact of this change.

Recent events have created inflationary challenges for school districts that will impact the supply chain cost of material and supplies, cost of labor as well as the tax Cap calculations. Schools will need to navigate these challenges through their long-term planning process and understand the impact of the use of appropriated fund balance and reserve.

Through our commitment to NYS School Districts, MMB+CO has been involved in interpreting and understanding the above noted items through our work with the Public Schools Accounting Committee and the Governmental Accounting and Auditing Committee of the NYS Society of CPAs and we have positioned our selves to provide guidance and remain current on these issues.
