#### Points of Interest

Board of Education Member Ronald Burke announced that the grand opening of the new pool will be Friday, June 6<sup>th</sup> starting at 2:30 p.m. noting that the swim team will be the first in the pool from 2:30 – 3:30 p.m.; there will be adult lap swim from 4:30 p.m. – 5:30 p.m.; and then a family swim period from 6:00 p.m. – 8:00 p.m. Mr. Burke commended the design and construction teams for a job well done.

Regular Meeting June 4, 2014

Mr. Burke noted there is a push for CPR across all schools in New York State, adding that a student was saved in the secondary building and that it was due to the fact that there were CPR and AED trained individuals in the building. Mr. Burke asked that others get involved by contacting their legislators to promote CPR training in schools.

Interim Superintendent Gary Mix followed up on comments by Mr. Burke noting that the family swim is being sponsored by the village and that the family swim time will be split into two sessions from 6:00 p.m. to 7:00 p.m. and 7:00 p.m. to 8:00 p.m. for safety and supervision reasons.

Mr. Mix thanked Watchdog Building Partners and SEI Design for the design and implementation of the pool project. Mr. Mix also thanked Director of Facilities and Transportation George English and Athletic Director Paul Giovine for their work on the pool plan, the safety plan, the Department of Health Certification and scheduling of lifeguards.

### Facilities Update

Todd LaBarr of Watchdog Building Partners gave an update on the capital project and presented a slideshow showing before and after photographs of the additions and renovations to the secondary building.

Mr. Mix thanked Kurt Vater of SEI Design and Mr. LaBarr on behalf of the district and Board of Education for all their hard work and dedication throughout the capital improvement project.

## **RER Energy Group Presentation**

Walt Pieschke of RER Design Group introduced Bob Harris from RER Design Group and Bob Raymond from Hunt Engineering and gave a presentation on a potential photovoltaic array and power purchase agreement for the district. This was followed by a period of questions and answers by the Board of Education. The Board of Education agreed to reflect on this and stated they would get back to RER Design Group with a response prior to July.
